Eric Cylvick called the meeting to order at 6:34 p.m.

## Minutes

MOTION: George Sears moved to approve the Minutes of May 9, 2024, as written. Eric Cylvick seconded the motion.

VOTE: The motion passed unanimously.

## **Unpaid Bills**

Trevor Townsend reviewed the unpaid bills. Eric Cylvick was the per diem for attending the Board meetings. Ferguson Waterworks was for 5 resetters that were ordered in October and another lid puller. George Sears was the per diem for attending the Board meetings. Hydro-Specialties was still showing a credit. KGC Associates was Carol's invoice. Pine Meadow Mutual Capital Account were the two accounts they chose to continue funding after they met the required loan escrow. Rocky Mountain Power was the monthly power bill. Scott Smith was the per diem for attending the Board meetings. The two Utah State Division of Finance were the loan payments. Verizon was for cellphones.

Eric Cylvick clarified that they were still contributing \$1,856 and an additional \$2,000 per month to the Capital Account.
